






Goals for 2008


- Enlarge the group of supporters for the UNOLS fleet both in terms of capitalization and operations.
- Extend our planning horizon to ensure that we are building a UNOLS fleet that really meets what the infrastructure needs will be for ocean sciences in the coming decades.
- Continuously work to lower barriers to effective use of UNOLS ships caused by disabilities, gender, or other special situations.

Operating the UNOLS Fleet: 2008 Ship Scheduling and Challenges




- •Overall higher costs (fuel, SOLAS, Homeland Security, etc.)
- •Fewer agencies supporting fleet operations at historical levels
- •Although ship demand remains high, budget constraints and higher costs result in fewer funded ship days.
- •In 2008: Operations face a deficit of ~\$10M. Agency reps, UNOLS, and schedulers are working on solutions.

UNOLS Fleet Renewal

Global Class:

UNOLS Council approved UNOLS Vessel Designation for R/V Langseth with contingencies for successful completions of reflagging, conversion and NSF inspection. NSF Inspection this week

Ocean Class:

- ARRV:
 - Cooperative Agreement UAF/NSF- 8/7/2007
 - Four phase project: deliver ~ 2011
 - Budget not to exceed \$122,930,218
- Navy AGOR Ships:
 - \$185M total budgeted for two ships
 - FY14: Deliver both ships

Regional Class:

- Three NSF Built Ships:
 - Phase I Design finish date 20 Mar 2008
 - Phase II Detailed Design & Construction proposed to start 1st quarter FY09
 - 27 month Phase II period for first ship

The Fleet Improvement Committee is working to complete the Fleet Improvement Plan

Equal Access at Sea

- We are making progress in ADA access.
 - ADA addressed in Research Vessel Safety Standard Update
 - ADA Guidelines document drafted and in review.
- Evidence suggests that we still need to increase awareness on what actions constitute sexual harassment and the negative consequences of such behavior on UNOLS vessels.
 - Exploring training resources.

Other Important Activities, Accomplishments, and Issues

- Introduced new UNOLS Ship time Request and Scheduling System
- Formed an Ad-Hoc committee to define best practices in Data Management
- American's with Disabilities Act (ADA) Guidelines for UNOLS Vessels - Final draft under review
- Update to Research Vessel Safety Standards coming soon.

- A model was created that schedules current ship time on a future fleet

- Updated the Ocean Class Science Mission Requirements at the request of Navy
