

UNOLS Council Chair Letter Highlights

- Letter sent 7 June 2011 on behalf of UNOLS in regards to the Gulf of Mexico Research Initiative RFP-1 released by the Gulf of Mexico Research Initiative Research Board.
- I hope that you will consider using UNOLS ships, underwater vehicles, and aircraft. As part of the national response to the Deepwater Horizon crisis, six UNOLS vessels participated in studies of the oil spill, which were supported by NSF, ONR, NOAA, and BP among others.
- UNOLS office, ship operators, and NSF were able to organize and plan scientific cruises on a relatively short time interval
- Over 40 years, UNOLS has utilized research ships owned by the National Science Foundation,
 Office of Naval Research, and state or privately owned vessels to successfully carry out a wide
 range of scientific missions.
- UNOLS vessels have broad capabilities; these vessels are staffed by experienced crew with a long record of safe and successful scientific operations.
- UNOLS fleet is a national facility that has a wide array of state-of-the-art equipment available to scientific users, as well as the technical support for this equipment pool. UNOLS office and individual ship operators are available to discuss logistics and cruise planning utilizing UNOLS assets.

RFP-I Letters of Intent due May 9, 2011, proposals due July 11, 2011- COL lead the peer review process, 1.0-7.5 million each, total 112.5 million, over 3 years, announcements made on August 31, 2011

Gulf Research Initiative RFP-III

- RFP-III process- Time Sensitive, for Immediate critical data to bridge until RFP I was completed, no collaboration, RFP-III Proposals due June 17, 2011, GRI Board Review Process, 50 K to 300 K, total 1.5 million, Announcements to be made June 30, 2011.
- Time Frame for RFP –IIII was July 1, 2011 to Sept 30, 2011.
- GRI received 111 proposals, 17 awards, totaling 1.5 million.
- Near Shore-Coastal, Beach work, no significant ship time.
