• This standard seeks to define the requirements, which must be adhered to during over-the-side deployments in order to maintain a safe working environment for all personnel aboard. The secondary goal of this standard is to minimize damage to tension members and handling equipment, and the loss of scientific equipment, while still permitting the science objective to be met.
