Call for Nominations to UNOLS Council

Nominating Committee: Peter Ortner (Chair), Larry Atkinson, and John Morrison.

Nominations are being sought from UNOLS institutions to fill four Council positions opening in 2012. Requirements for the positions are as follows:

One Chair-Elect Position - affiliation with any UNOLS institution.

One At-Large Position - affiliation with any UNOLS institution.

One Non-Operator Position - affiliation with a UNOLS non-operator institution.

One Operator Position - affiliation with a UNOLS facility operator institution.

The term for the Chair-Elect is two years, followed by being UNOLS Chair for two years, and Immediate Past Chair for two additional years. Terms of office are three years for Council Members with the possibility of reelection for a second term.

Nominations for the slate may be submitted by anyone affiliated with a UNOLS institution to square.

A 2-page CV and statement of interest with nominations are due by June 30, 2012. Nominating Committee must give due consideration to the qualifications of nominees. maintenance of regional and disciplinary balance on the Council.

The committee will then recommend a slate of candidates that will be voted upon by the UNOLS membership at the 2012 Annual Meeting in the fall.
