 - Unmanned aircraft and other systems for inclusion in ship operations Phil McGillivary will report on coordination of UAS with ASVs and AUVs, and the ship capabilities required for optimal data ingestion. Issues of launch and recovery of unmanned systems will also be discussed. (20 minutes)
