#### To Whom it May Concern,

I hereby tender my application for the position of Captain or First Mate onboard larger yachts requiring credentialed crew. As a proven maritime expert with impeccable qualifications, I seek to transition from another highly demanding and rigorous career within the maritime industry to the community of yachting professionals. If you consider the totality of my experience, skills, and qualifications, I am confident you will determine that I am highly qualified and desirable for professional service onboard large motor and sail yachts. I include 'sail' because many of my skills also directly translate to service onboard large sail yachts (especially in an introductory capacity as First Mate). Bottom line, if you are seeking an intelligent, experienced, and dedicated individual whom you can trust to handle these precious assets, my name should be present on any short list of prospective Captain or First Mate candidates.

My shiphandling skills, maritime expertise and leadership abilities were developed, tested and proven during a successful 15-year seagoing career with the United States Coast Guard. With nearly a decade of direct assignment to USCG ships (including as Captain of a Seagoing Buoy Tender for three years in Kodiak, Alaska), I am wellversed in piloting large, valuable vessels in exceptionally demanding situations, not to mention while also training and leading large crews in the execution of important U.S. national maritime priorities. I was deemed an exemplary leader who loved his crews and consistently fostered a work environment that brought out the best in people, as evidenced by the many awards and recognitions we received. I ask that you consider how the additional skills retained by a former USCG Commanding Officer might further complement the sort of skipper any yacht owner or agency would want managing their vessel.

Furthermore, as a top-performing officer in the USCG, my selection to serve as Commanding Officer was preceded by my competitive selection to attend graduate school in International Affairs; upon completion of my graduate degree, I was assigned to the prestigious role of DHS Attaché and Maritime Operations Advisor to the U.S. Ambassador for the Bahamas and Turks and Caicos Islands (TCI). Serving successfully for two years in this capacity (for which I was later awarded the U.S. Meritorious Service Medal), I became intimately familiar with the governments and waters of both countries, consequently developing an extensive network of Bahamian and TCI contacts in the industry. Given that many large luxury yachts ply the waters of both countries, I am confident that a yacht owner or agency will also find these qualities to be of significant value in selecting your next Captain or First Mate.
