



# UNOLS Office – 2nd Term Renewal




- Working through new Cooperative Agreement with NSF and new grants / contracts with the other funding agencies (ONR, NOAA, USGS & BOEM).

# Legislative Action regarding the ARF



•Proposal: Statutory amendments to 46 U.S.C. that will allow the vessels of the Academic Research Fleet (ARF) to function in a favorable and

stable regulatory environment.

•Intent: With a clear set of statutory directives, operators of ARF will not have to depend on interpretations of individual U.S. Coast Guard

(USCG) officers, the USCG Commandant, other federal agencies, or the courts.

•Proposed Changes: The proposed to title 46 of the U.S. Code (46 U.S.C.) should:

(1) Have ARF vessels of the participate in the inspection regime administered by the USCG, of subtitle II of title 46 U.S.C.;

(2) Exempt ARF vessels from the federal pilotage requirements of 46 U.S.C. § 8502;

(3) Ensure, to the extent possible, that ARF vessels are treated as public vessels for purposes of international law by the U.S. Department of State;

(4) Allow ARF vessels, their operators, and their operators' employees and agents to take advantage of the protections of the and the Suits in Admiralty Act (SAA), 46 U.S.C. §§ 30901

-18, and the Public Vessels Act (PVA), 46 U.S.C. §§ 31101-13;

(5) Ensure that members of a science party, without regard to their employment status on any Oceanographic Research Vessel (ORV) are not able to seek the remedies provided to

"seamen." under the Jones Act, and the judge-made general maritime law of the United States; and

(6) Ensure that members of the science party, whatever their employment status, on any ORV are not considered "passengers".

### Legislative Action Continued

• We intend to review & share the proposed changes to 46 U.S.C with Council and the UNOLS Ship Operators with an

intent to develop a consensus for the proposed language and moving ahead with pursuit of the changes.

• We will need to develop a strategy with the UNOLS Community, particularly the Operating Institutions, for pursuing





- Subj: GUIDANCE ON SURVEILLANCE REQUIREMENTS FOR CERTAIN COMMERCIAL VESSELS THAT DO NOT CARRY PASSENGERS
- Ref: (a) James M. Inhofe National Defense Authorization Act (NDAA) for Fiscal Year 2023, SEC 11607 (H.R. 7776 page 1756) Surveillance Requirements
  (b) Title 46, United States Code (U.S.C.) § 4901 Surveillance requirements
- <u>PURPOSE</u>. This policy letter provides clarification, policy, and guidance to the Officer in Charge, Marine Inspection (OCMI), Recognized Organizations (RO), and the maritime industry on reference (a) regarding surveillance policy requirements as codified in reference (b).

# Safer Seas Act

- USCG has recently concluded ARF vessels are not Public Vessels (CG Policy Letter 24-01)
- Required to comply with Safer Seas Act (SSA)
  - Enacted as part of the National Defense Authorization Act for the fiscal year of 2023 to combat sexual assault and harassment (SASH) aboard vessels
- 4 Primary Elements
  - Safety Management System (SMS)
  - Key Control
  - Signage
  - Video Surveillance System
- UNOLS Office to facilitate efforts
  - SMS, Key Control & Signage -
    - Is operator/ship specific
    - UNOLS to coordinate / facilitate sharing of information & best practices amongst operators for
    - Meegan Corcoran will assume this role for the UNOLS Office

### Safer Seas Act Continued

- Video (and audio) Surveillance System
  - Contract for a stand-alone system that can be procured, installed, and supported on ships by a contractor
  - Coordinate with UNOLS Ship Operators
  - Focus on Global & Ocean Class vessels (8 ships) first as they undergo regular USCG inspections to maintain their Certificates of Inspection (COI)
  - Coordinate with RCRV program as those ships will also have COIs
  - Address Regional, Coastal and Local class vessels after
  - Doug Russell will manage this aspect of the SSA implementation
- Where are we currently?
  - Decision made this week to move ahead
  - Identifying possible solutions
    - Digigone is one solution
      - Standard package of cameras, microphones, secure server based on ship's general arrangements
      - 2-3 installation by a 2-person team
      - Tested remotely monthly with reports provided regarding the status & health of each ship's system
      - Data stored in a locked secure server onboard the ship
      - If video is required for an investigation, Digigone reaches in via satcom to upload requested video and then download to a secure source that is delivered to the authorized recipient. No crew involvement
      - Data (video & audio) is retained on server for at least a year per USCG regulation
    - Investigating other possibilities / possible solutions / suppliers
  - Will start on development of a contract that will be executed through UW Procurement
  - Intend to install for all berthing area passageways crew, marine techs & science party to afford increased safety / security for all
  - Will share plans with the UNOLS Community as the plans solidify
